

Batchelors Peas Train With A Team Terms & Conditions

These Terms and Conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. Entry/claim instructions are deemed to form part of the terms and conditions and by participating, all claimants will be deemed to have accepted and be bound by the terms and conditions. Please retain a copy for your information.

1. Eligibility: Competition is open to community rugby league players of all age groups and school teams – winners will have to provide proof of belonging to a club/team. Entrants must be resident in the UK. Employees of RFL (the 'Promoter'), Princes Limited and either of those parties' immediate families, agencies, associates, printers or anyone professionally connected with the promotion are excluded.
